ADVERTISING NETWORK AGREEMENT

By advertising with EDN, the Advertiser agrees, without limitation or qualification, to be bound by, and to comply with, these Terms and Conditions and any other posted guidelines or rules applicable to EDN's digital advertising services.
- 5. **LIMITATIONS OF LIABILITY** - In the event that EDN fails to publish an advertisement in accordance with the schedule provided in the Advertising Agreement, or in the event that EDN fails to deliver the full time period of the Advertising Agreement (if any), or in the event of any other failure, technical or otherwise of such advertisement to appear as provided in the Advertising Order, the sole liability of EDN and exclusive remedy of Advertiser shall be limited to placement of the advertisement at a later time in a comparable position until the total advertising time is delivered.
- 6. **ENTIRE AGREEMENT** - It is agreed and understood by both parties that this Agreement constitutes the entire agreement between parties and supersedes and replaces all other prior understandings or agreements relating to the premises covered by this Agreement. This Agreement may not be changed, modified, or altered in any manner except in writing and signed by an authorized representative of EDN.
